No. GLR.147/2008/102 : On the recommendation of the Assam Public Service Commission (A.P.S.C.) and subject to discharge without notice and without assigning any reason thereof, Smti Nandana Sarma is appointed on purely temporary basis as Inspector of Boilers in the Scale of Pay of Rs. 12000 - 40000 (PB-4) with Grade Pay of Rs. 5400 per month plus other allowances as admissible under the Rules and posted at office of the Sr. Inspector of Boiler, Dibrugarh against existing vacancy.

The candidates so appointed shall not be governed by the existing Assam Services (Pension) Rules, 1969 and orders issued there under from time to time. She will be governed by a new act of Pension Rules which are being formulated in the line with Contributory Pension Scheme announced by the Govt. of India recently.

She is requested to join in her respective place of posting within 15(fifteen) days from the date of receipt of the notification, failing which her appointment will stand cancelled.
